## Rationale

As a school we aim to develop the holistic needs of our pupils. The teaching of religious education (R.E.) is central to this commitment.

R.E. well taught is academically stimulating but it also develops character traits, helps pupils make ethical decisions and allows them to understand their world in a fuller way. They are allowed to develop their own spiritual perspective on their experiences and those of others in the past and in the present, including those in the local community.

As a school we are striving to pursue opportunities for Shared Education. We believe this requires pupils to have a firm understanding of the role of religion in their own tradition. With this context they will have the knowledge, confidence and respect of faith to explore the similarities and difference of other traditions both locally and globally. The development of R.E., therefore, is a crucial element of our school's strategic development.

Whitehouse Primary School has a welcoming Christian ethos. We believe that our school is enriched by the values and actions that flow from our core beliefs. It must be stressed that our ethos is embracing to families of all Christian traditions, other religions and those of no stated faith. Therefore, our teaching of R.E. is more than an academic opportunity but it is a means to build a caring and cohesive community.

As a school we have decided to parallel our collective worship with our R.E. curriculum. Our three year rolling teaching curriculum, which links with weekly assemblies, allows for continuity and a broad range of study. It also, however, brings a whole school community experience of R.E. The partnership enriches the curriculum and collective worship.

#### Aims

We hope to provide high quality R.E. learning for our pupils. This teaching is underpinned by some key agreed aims.

- 1. Our pupils will have a broad range of biblical and religious knowledge.
- 2. The pupils will be able to apply their biblical knowledge to their local and wider contexts.
- 3. Pupils' will be equipped to make decisions that improve their happiness and health.
- 4. Our school will be a more positive and caring environment.
- 5. By understanding faith, and its outworking, pupils will appreciate its role in society.
- 6. Pupils will be empowered to challenge negative attitudes towards the faith of others.
- 7. Our pupils will embrace respect and reconciliation in our local and wider society.
- 8. Pupils will enjoy learning via R.E. and be encouraged to have a desire to find out more.
- 9. Flexible thinking and creativity will be fostered.
- 10. Literacy and numeracy skills of pupils will be improved via their application.
